1. Electronic document processing

The exchange of business documents by mail or fax does not just cause high costs for paper and postage but also major environmental problems. Even for free text emails, employees must enter data in the EDP systems which in turn poses a risk of mistakes. Moreover, the time for transport and processing is enormous. Therefore, Mercateo attempts to allow for the automated and smooth exchange of business documents.

This documentation describes different transaction processes and the involved business documents which can be used for the electronic document processing between clients and Mercateo. These business transactions include ordering, shipping and billing processes.

In order to reproduce documents such that they can be processed automatically, different standards are supported, both regarding document formats and transmission methods.

2. Overview of the different types of interfaces

Mercateo provides different interfaces for the transmission and reception of electronic business documents.

2.1. OCI - Punch Out

- Creating purchase order requests

2.2. Incoming documents

- Sales orders, at Mercateo referred to as order inject
- Credit notes / debit notes

2.3. Outgoing documents

- Order confirmation
- Dispatch notification
- Invoices / credit notes

3. Supported formats and transport protocols

Mercateo aims at the **easy, fast and above all flexible connection of the different systems of our customers**. Therefore we support multiple formats and transport protocols.

3.1. Supported formats

Mercateo internally uses the "openTrans" standard 1.0 format.

However, it is not a problem to transform your formats, e.g.:

- XML and derivatives such as
 - openTRANS
 - chemXML
 - ebXML
 - xCBL
 - cXML
 - and others
- SAP: SAP-IDOC (all language versions)
- EDIFACT (all language versions)
- Record type formats (CSV)
- and others on request

3.2. Supported protocols

- HTTP and HTTPS
- AS2
- FTP
- POP3 / SMTP
- and others on request

4. Connection process

4.1. Phase 1: Initiation

First of all, a member of the Mercateo sales and/or project management division will consult you. On the basis of these consultations, a member of Mercateo's EDI team will contact you in order to define the format and transport protocol for each interface. Furthermore, special features regarding content will be discussed. Then you provide your interface description.

4.2. Phase 2: Development

For the creation of test documents, a test environment is installed at Mercateo and, if possible, also at your place. Access is provided at both sides where these test documents can be addressed to. The preliminary exchange of test data by email is also possible. On the basis of the test documents, the conversion process is started at Mercateo. For the correct interpretation of these submitted documents, among others, it may be necessary to correct them.

4.3. Phase 3: Test

This phase is closely linked with the development phase. Each interface with their arranged accesses is tested together with you.

4.4. Phase 4: Live

After the tests have been completed successfully, the accesses for the transmission of the real documents are installed at the Mercateo live system as well as at your place, and conversion is activated.

5. Description of possible interfaces

5.1. Provision of the shopping basket via interface (OCI / cXML)

Using the so-called punch-out method (OCI / cXML), buyers can enter the Mercateo procurement platform from your ERP / SRM. On this platform, buyers choose their desired items thus creating a shopping basket at Mercateo which is transmitted to your ERP / SRM systems as an offer and can be checked and approved by your responsible staff members as a purchase order request before triggering the purchase order for Mercateo.

Technically, a button is installed in your ERP / SRM which includes a link with parameters configured for you. Clicking on this button, buyers / purchase order requesters trigger the entering process onto the Mercateo procurement platform. After having chosen all items, there is a button in the shop which transmits the purchase order request to your system.

Detailed information on OCI are provided in the "Mercateo – OCI process" documentation.

5.2. Purchase orders for Mercateo (order inject)

Instead of submitting purchase orders for Mercateo by mail, fax or free text mail, an electronic interface can be set up for the transmission of purchase orders.

Once we have agreed on your desired document format, contents must be discussed and implemented. To this end, the following aspects regarding content must be discussed and observed:

- For the unique identification of the customer, the **customer number** assigned by Mercateo must be indicated in the ORDER.
- The Mercateo customer service requires the **contact data of the buyer** (name, telephone and / or email address) for possible queries.
- If possible, the **shipping address** should only be transmitted on head level.
 - Note: If the shipping address is transmitted on item level, there is a risk that the order is split which would involve higher shipping costs. The undesired splitting of the order may already be caused if the shipping addresses in the item deviate by just one character.
- The name fields of each address are restricted to max. 35 characters.
 - Note: Any important supplier information which is to be printed on the package label must be placed in the first two name fields of the shipping address since many Mercateo suppliers only process max. 2 name fields.
- If there are several **invoice addresses**, the corresponding invoice address must always be transmitted with the purchase order.
- The correct **invoice address** of the corresponding Mercateo subsidiary must be included.
- It is possible to transmit the **payment method** (invoice or direct debit) in the ORDER.

Upon order receipt, an order response (note: this is not a purchase order confirmation) is automatically sent to the email address of the buyer indicated in the ORDER or to a default email address saved in the system. With this order response, Mercateo only acknowledges the receipt of the order.

5.3. Dispatch notifications from Mercateo

In order to confirm the dispatch of the goods (list of services), we can send you the dispatch notification as a file.

As soon as the dispatch notification or the invoice has been provided by the supplier, Mercateo will send them out. In some cases, the dispatch notification and the goods may be received at the same time. This is usually provided by Mercateo as an *openTrans DISPATCH NOTIFICATION*. If requested, we can also convert it into your desired format.

5.4. Invoices from Mercateo

As a standard, you may choose if you want to receive the invoice by email with attached signed PDF or SAP-IDOC format *INVOIC01* or by mail.

Another alternative is to set up an interface for invoice dispatch

which is used to send the invoices as files in your desired format.

The following types of documents are displayed and/or transmitted in the invoicing process.

- Invoice
- Credit note (for an already created invoice)
- Cancellation of invoice

5.5. Credit notes for Mercateo

If you have agreed on credit note procedures with Mercateo instead of the aforementioned invoices, the following applies: Upon request, we set up an interface for the exchange of required files in your desired format. In addition to the ways of transport listed above, we also accept credit notes by mail or fax.

The following types of documents are processed in this context.

- Credit note
- Debit note

Requesting a credit note for Mercateo

- Document date
- Consecutive document number
- Full name and full address of the Mercateo subsidiary
- Tax ID number of the Mercateo subsidiary
- Full name and full address of the service recipient
- Tax ID number of the service recipient
- Shipping address
- Date of shipping
- Purchase order number
- The supplied items with item no., designation, tax rate and tax amount as well as net amount
- Corresponding total amounts

6. Standard formats at Mercateo

For order inject, dispatch notification and credit note, Mercateo uses the *openTrans 1.0* XML format.

For further information, specification and sample documents (including descriptive XSD and DTD files) are provided at www.opentrans.org in the download section.

The sample documents provided on the following pages meet the minimum requirements of the *openTrans* standard, and some of them include additional data for easier document processing and/or additional information (e.g. package number).

The *openTrans* specification documents provide detailed information on whether data are mandatory or optional.

6.4. CREDIT NOTE

openTrans 1.0 which is used at Mercateo does not have any standard format for credit notes or debit notes as a standard. This is the reason why the format for invoices (INVOICE) is used here.

7. Transmission of documents

Documents can be transmitted by HTTP, HTTPS, AS2, FTP or email.

7.1. HTTP / HTTPS

Transmission of the documents to the indicated target URL by HTTP or HTTPS-POST.

The explicit port approval in the firewall of your system might be required to this end.

The target URL and the target port for the transmission of documents as well as any certificates, if required, are exchanged during the connection phase.

7.2. AS2

Transmission of the documents to the indicated target URL by AS2.

For authentication, certificates must be exchanged at first.

AS2 is based on the HTTP transport protocol and specifies how to connect with each other and how to validate, send and confirm messages. It creates an envelope for each message and securely sends it via the internet. Authorship is ensured by digital signatures, and data security is ensured by encryption. The sender (here the supplier) receives a digital receipt of delivery from the AS2 protocol, referred to as Message Disposition Notification (MDN) in AS language, which the sender can use as proof for on-time delivery.

The target URL and the target port for the transmission of documents as well as any required certificates are exchanged during the connection phase.

7.3. FTP

Documents may be exchanged via your FTP server or an FTP server provided by Mercateo.

The access data for the transmission of documents are exchanged during the connection phase.

7.4. Email

Documents are transmitted as email attachments.

The email address for the transmission of documents is exchanged during the connection phase.
